ASSESSMENT PROCEDURE AND PERCENTAGE WEIGHTAGE OF MARKS



Course work is divided into 10 semesters. Each year a student has to take up minimum of six papers in each semester. All semester-end examinations for the theory courses, except for clinical legal education papers, will be conducted for 100 marks which will be scaled down to 75 and added to 25 marks which is allotted for internal examination. This will be the final aggregate marks in a course. There is a 2-tier passing system wherein a student has to pass with minimum of 40 % both in the semester end exam which is for 100 marks and also in the case of aggregate marks (75 + 25) as well.

INTERNSHIP

The evaluation process will be based on the internship report submitted by the concerned student and a viva-voce conducted by an expert committee constituted and appointed by the Dean of school. The total mark and credits allotted shall be assessed and awarded in the Final Semester of the course in the 4th Clinical course as stipulated under the Rules in Schedule II of Rules of Legal Education issued by the Bar Council of India. All assessments of a course will be made on absolute marks basis. However, the Class Committee without the student members shall meet within 5 days after the semester-end examination and analyze the performance of students in all assessments of a course and award letter grades. The letter grades and the corresponding grade points are as follows:

- "W" denotes withdrawal from the course.
- "I" denotes inadequate attendance and hence prevented from semester-end examination
- "U" denotes unsuccessful performance in the course.

The faculty members conduct an interview and shortlist the members who are suitable for the moot according to their zeal to work and learn.

Placement Rules

Registration

Pre-interview Screening Process

Pre-interview Screening Process may be conducted any time before the final interviews. Recruiters are free to determine their own policy for the process of shortlisting students. In case the recruiter has no policy of Pre-screening, the Curricula Vitae of all interested students shall be forwarded to the Recruiter and the list shall become Final Interview List.

Preferred date and time of final interview shall be communicated to Placement Committee for necessary arrangement of the same.

Disclosure of Offers

After the interviews, recruiters are required to make final offers to shortlisted candidates mentioning the roles, remuneration, location and other relevant terms and condition required to decide. A copy of offer letters shall also be sent to Placement Committee by the recruiter for the records. Acceptance/Rejection of offer shall be communicated by the concerned student to the recruiter. Copy of such communication shall also be marked to Placement Committee.
