In accordance with a mutual desire to promote co-operation between FRONTIER LIFELINE (DR. K. M. CHERIAN HEART FOUNDATION) & FRONTIER MEDIVILLE Chennai and B.S. ABDUR RAHMAN CRESCENT INSTITUTE OF SCIENCE & TECHNOLOGY, CHENNAI, the two Institutions hereby agree to enter into this agreement for promoting academic, research and related activities between the two.

1. The two Institutions shall encourage direct contact between their faculties, administrators, departments, schools and research centres in order to promote this co-operation.
2. Within the areas that are mutually acceptable, cooperation will be pursued in:
 - ❖ Joint research projects of mutual interest.
 - ❖ Joint animal experiments
 - ❖ Exchange of faculties for research, teaching and collaboration.
 - ❖ Exchange of graduate and undergraduate students for study and research.
 - ❖ Exchange of information including, but not limited to exchange of library materials and research publications which is of mutual interest to both Universities.
 - ❖ Access to various research facilities of the institutions by the collaborating faculty.


Implementation:


- (a) Both institutions shall agree to seek financial support for mutually agreed cooperative activities from appropriate funding agencies
- (b) Both parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds for each collaborative project.
- (c) The implementation of these activities will be developed mutually for specific projects. The Memorandum of Understanding will have, from time to time, annexure attached to it with regard to these specific projects.

- (d) This agreement comes into force on the day when representatives of the two institutions affix their signatures, and is valid for five years. The institutions agree to review it after five years from the date hereof.
- (e) The notice of termination of this MoU needs to be given six months in advance by either side.

Hereupon, the undersigned signatories agree to the above provisions of the agreement.


