SCOPE OF THIS MEMORANDUM OF UNDERSTANDING

To promote co-operation between Pentagrit Research and B.S. Abdur Rahman University, Chennai, India for promoting research related activities between the two.

1. The two Institutions shall encourage direct contact between their faculties, administrators, departments, schools and research centres in order to promote this co-operation.
2. Within the areas that are mutually acceptable, cooperation will be pursued in
 - Joint research in Zebrafish model
 - "HRCOXE" for screening of compounds from BSAU and Whole Animal Imaging, Pathology and Behavioral Models screening.
 - Exchange of faculties for research, teaching and collaboration.
 - Exchange of students for study and research
 - Exchange of information including, but not limited to exchange of library materials and research publications which is of mutual interest to both Institutions.
 - Access to various research facilities of the institutions by the collaborating members
 - International business training for students
 - Collaboratively identify HITS that could help sell / brand a few of BSAU library compounds to the market driving ROI to both B.S. Abdur Rahman University and Pentagrit.

Implementation :

The implementation of these activities will be developed mutually for specific compounds. The Memorandum of Understanding will have from time to time, annexure attached to it with regard to the specific research project.


This agreement comes into force on the day when representatives of the two institutions affix their signatures, and is valid for five years. The institutions agree to review it after five years from the date hereof.
