REPORT ON 'WORKSHOP ON MOOT COURT' ORGANISED BY MOOT COURT SOCIETY

9th September, 2022



On 9th September 2022 a workshop on "moot court' was organised by the Moot Court Society for the students of Crescent School of Law. The workshop was held in 3rd floor auditorium, Mechanical Science Block in B S ABDUR RAHMAN CRESCENT INSTITUTE OF Science and Technology.

WELCOME ADDRESS was delivered by Mr. Shahnawaz Ahmed. The resource persons for the workshop were Advocate Balaji A.P. and Advocate TanviKankaria. The resource persons were formally introduced by Ms. NashitaNazneen (B.B.A LLB. X semester student).

Technical session I was headed by **Mr. Balaji A P**discussed the basics of mooting starting from the concept of mooting itself. He explained the meaning of mooting and its significance for a law student. He went ahead to explain in detail how to form a team for moot court and the format of a moot court competition. He pointed out that while reading a moot court proposition one should focus on the timeline of facts thereby extracting relevant information, this makes identifying issues easier for the participants. He also focused on the practical aspect of the participation such as how to decide on partners. Compatibility, reliance and professionalism are the points to be kept in mind while choosing partners for a moot court competition.

Technical session II was lead by **Ms. Tanvi Kankaria** who dealt with 'Art of mooting'. She meticulously explained the various parts of a memorial. Beginning with drafting of the memorial, she stressed on the importance of having one's own unique style which will attract the judges of the competition. She discussed the format of the memorial- the font, headings etc., Her session covered various points on which a team is awarded points in a moot court competition; it included the drafting of a memorial, speaking skills, the manner, matter, method of presenting and rebuttal. The session was concluded with pointers on what kind of approach one can take while speaking depending upon the temperament of the judges.

The workshop was brought to an end with the **VOTE OF THANKS** delivered by Ms. S.Saba. She thanked the resource persons for taking out their valuable time, Mr. Shaji M. (Dean I/c) Crescent School of Law for his support in conducting the workshop, the organisers for smooth functioning and the volunteers involved.
